WHEREAS on April 20, 2021, the Review Committee (COMEX) received, for its recommendation, the environmental and social impact assessment for the project to build a new wastewater treatment plant in Wemindji. After reviewing the document, COMEX submitted questions and comments to be addressed to the proponent on July 22, 2021, to clarify various aspects regarding the project. COMEX received the proponent's answers to the questions and comments on September 2, 2021.

WHEREAS the COMEX members reviewed the documents submitted by the proponent and, based on the information contained therein, COMEX recommends that the Regional Administrator authorize the project with one condition (condition detailed in the letter).

The COMEX members discussed the article entitled "Milieux humides – Québec très loin de son objectif" published in *La Presse* on October 8, 2021. They would like details regarding the surface area of the wetlands lost as well as the financial compensations cited in the article, especially in the James Bay region. Sophie Cooper will see if it's possible to organize a meeting between the COMEX members and one or more of the Québec government officials working on the wetland compensation plan.

b. New owner of the Moblan Lithium project

The members were informed that Sayona Mining has acquired the Moblan Lithium project.

c. Cree-Québec Forestry Board

The COMEX members went over the Cree-Québec Forestry Board's 2020-2021 annual report and noted that the format was more administrative than previous annual reports. Sophie Cooper will see if it's possible to organize a meeting between the COMEX members and one or more representatives of the Cree-Québec Forestry Board.

d. Research project CC22.1 – "Portrait climatique EIBJ-Nunavik-AT" / Monitoring Committee meeting: Presentation of final results

The project leader, Anick Guimond, sent a Doodle survey to several members of the monitoring committee to get their availability for a presentation of the final results. Sophie Cooper will represent COMEX at the meeting, which is scheduled for January 2022.
