The certificate of authorization for construction of a new municipal solid waste disposal site near Waswanipi was issued on March 10, 2017. Condition 2 of the certificate of authorization stipulates that the Cree First Nation of Waswanipi must submit to the Regional Administrator, for approval, a post-closure restoration plan for the disposal site previously used by the community.

WHEREAS on March 30, 2020, the Review Committee (COMEX) received, for its recommendation, a restoration plan for the old disposal site. On July 9, 2020, COMEX sent the proponent questions and comments regarding the proposed restoration plan. The proponent's answers to the questions were received by COMEX on October 5, 2021.

WHEREAS the COMEX members reviewed the documents submitted by the proponent and COMEX would like the proponent to clarify certain answers that it deems incomplete.
