A second version of the review report for the Rose Lithium-Tantalum Mining Project was submitted to COMEX for reconsideration. Following comments and questions submitted by the MELCC and CNG analysts, COMEX is waiting on verification of certain aspects of the project. A third version of the report will be submitted for COMEX's review and approval at the next meeting.

5) Extension of Route 167 North to the Otish Mountains, Ministère des Transports du Québec (MTQ)

WHEREAS on March 3, 2022, the Review Committee (COMEX) received the answers to the questions and comments sent to the proponent on January 15, 2018, regarding the MTQ's project to extend Route 167 North to the Otish Mountains. The goal was to determine whether the proponent's answers constituted sufficient follow-up on the authorization conditions.

WHEREAS the COMEX members reviewed the documents submitted by the proponent and were satisfied with the proponent's answers to the questions concerning conditions 4, 7, 20 and 23. COMEX considers that these conditions have been met.

WHEREAS COMEX will write to the Provincial Administrator with its comments regarding the following conditions:

Condition 5: Installation of signs at the limits of wildlife reserves

Although it was determined that the proponent had answered the question in a satisfactory manner, the signs don't appear to have been installed in 2021, presumably because the Nibiischii national park was still being created. The proponent had pledged to post the signs. In order to meet condition 5, the proponent must confirm that signs have been posted at the limits of Albanel-Mistassini-and-Waconichi Lakes wildlife reserve and the Albanel-Témiscamie-Otish (now Nibiischii) park.

Condition 6: Creation of a special hunting and fishing zone

Although it was determined that the proponent had answered the question in a satisfactory manner, having provided the requested update, discussions with the stakeholders, in particular the Cree Regional Administrator and the Hunting, Fishing and Trapping Coordinating Committee, have not yet begun. The proponent says that it will provide the follow-up on this condition at a later date. COMEX is still waiting to receive this follow-up.

Condition 24: Woodland caribou protection

In 2018, COMEX asked the proponent to submit the results of the woodland caribou monitoring program. The proponent says that discussions with the stakeholders, in particular the Cree Regional Administrator and the Hunting, Fishing and Trapping Coordinating Committee, have not yet begun. The proponent says that it will provide the follow-up on this condition at a later date. COMEX is still waiting to receive this follow-up.

6) Eastmain-1-A and Rupert diversion project

a) Water quality monitoring in the Rupert and Nemiscau rivers – 2017

> For information

WHEREAS on January 14, 2020, the Review Committee (COMEX) received, for information purposes, the water quality monitoring report (2017) for the Rupert and Nemiscau rivers. The monitoring was a requirement of condition 6.6 of the certificate of authorization issued on November 24, 2006 and condition 1 of the amended certificate of authorization issued on July 28, 2008.

Following the partial diversion of Rupert River in November 2009, Hydro-Québec had to monitor the quality of water in the Rupert and Nemiscau rivers downstream of the Rupert diversion bay based on domestic uses, not including drinking water. The following parameters were measured: colour, turbidity and suspended solids (SS) concentrations.

WHEREAS the COMEX members reviewed the documents submitted by the proponent, including the monitoring results since 2008, and considering that the monitoring conducted achieved the set objective of determining changes in water quality related to domestic use. The monitoring results are consistent with the assumptions noted regarding the project's potential impacts on the water quality of the Rupert and Nemiscau rivers. However, some perceptions regarding the quality of the water persist within the Cree community. In fact, these perceptions are mentioned in other reports produced by Hydro-Québec following consultations with Cree land users. COMEX will comment on the matter after it analyzes and reviews these reports.

8) Meeting 406 B: July 27, 2022, at 9:00 a.m.

Discussion of cumulative impacts and actions proposed by the James Bay Advisory Committee on the Environment (JBACE) – JBACE participants: Graeme Morin (analyst), Suzie Boudreau and Marc Dunn

The JBACE conducted a diagnostic analysis of issues and potential solutions related to assessment and consideration of cumulative impacts in development projects subject to environmental and social impact assessment and review under Chapter 22 of the James Bay and Northern Québec Agreement (JBNQA) and in the context of land use planning and the regional policy.

The goal of the meeting was to have an open discussion on the four courses of action identified in the diagnostic analysis to better guide the JBACE's future activities and efforts. The aim is to focus the JBACE's efforts on relevant, achievable and practical targets.

During the meeting, it was mentioned that creating a database or other methodological aspects of the traditional approach to cumulative impact assessment would be laudable, but would not necessarily inform decision making. Instead, it would be worth exploring developing a tool designed to take into consideration the environmental and social support capacity of a specific area or region for new projects. The COMEX members suggested that the JBACE's efforts could be better placed by focusing on the regional policy and land use planning.
