1. CALL TO ORDER AND ADOPTION OF THE AGENDA

The meeting was called to order at 1:45 p.m. The agenda was amended to remove Item 10 and was adopted.

2. ADOPTION OF THE MINUTES OF THE 291st AND 292nd MEETINGS

Amendments proposed to these minutes since the last meeting have been included. New amendments were suggested for the minutes of the 292nd meeting, and amended minutes were adopted.

3. CORRESPONDENCE SINCE THE LAST MEETING

A list of correspondence sent and received since the last meeting is attached to the minutes. One item was added – the submission of the Cree Regional Authority for the public consultations on the Stornoway mining project.

4. EXTENSION OF ROUTE 167-Nord

On September 25, 2012, the Department of Transport sent additional information concerning the stability of materials and also the environmental monitoring program they plan for borrow pits that have not yet been authorized. The MTQ's letter stated that the Department intends to carry out the monitoring without supplying any additional information about the biophysical description of the sites. However they specify that they will supply complete information for the borrow pits located north of KM 143. By agreeing to these requests, the MTQ will provide COMEX with the necessary information to authorize 35 borrow pits. The monitoring program proposed by the MTQ is similar to what COMEX proposed for the authorization of borrow pits D-93C, D-95-100 and D-115. Given this, the MTQ proposal is an acceptable compromise that would allow us to authorize operation of borrow pits within 75 m of lakes and waterways. One member abstained from commenting on this. Members also recommended that the MTQ be asked to provide, in its environmental monitoring report, a portrait of the current situation, supported by photos, of borrow pits before operations have begun. In addition, given the information sent regarding stability of materials on esker deposits, it will be specified in the letter accompanying our recommendations that borrow operations be carried out only on eskers.

A Table was presented showing all the requests from the MTQ for modifications to the certificate of authorization. The Table identifies all the locations that have been authorized as well as the ones for which we are awaiting more information.

5. MISTISSINI BRIDGE, BORROW PIT AND ACCESS ROAD PROJECT

A technical meeting was held in Mistissini on September 18 with the consultant and representatives and of the Band Council in attendance. The meeting included a presentation on the design for the bridge construction. According to the Band Council representatives, accessing borrow pit materials near Mistissini is difficult not only because they are scarce, but also because the MTQ are using them for the extension of Route 167-Nord. The costs for the bridge construction and maintenance are equivalent to the costs for transporting materials long distances over existing roads. However, construction of the bridge would open the way

for expanding the village in this sector. The Band Council would like a decision in early October so that they could start work before winter.

COMEX members were satisfied with the answers received during the meeting and have a better understanding of the rationale for the project. However they think the bridge design is questionable and do not see the need to move the floatplanes below when another location could be used for aircraft landing and takeoff. It could be built lower down which would also reduce construction costs. Likewise, it is not entirely clear that the project has the support of the people of Mistissini. The biophysical aspect of the analysis is not completed, but conditions can be expected in this regard. Members agreed to aim for around October 15 as their target for formulating recommendations. Members were asked to provide drafts of conditions to the Executive Secretary for the purpose of preparing the draft recommendation.

6. ELEONORE MINING PROJECT

We received a request for modification to the certificate of authorization relating to four items, including construction in October of a temporary tailings storage site. It was proposed that members give priority to analysis of this request, and deal with the others later this fall. However, six elements have to be clarified with the proponent before making a recommendation, including the source of the tailings so that we can determine if there is potential for acid mine drainage, as well as storage duration, spot elevation, water treatment, treatment sites, and finally, restoration method. Members agreed to discuss a draft recommendation at the meeting scheduled for October 10.

7. PUBLIC CONSULTATIONS ON EASTMAIN-1-A

We have received confirmation from all communities for the dates of the public hearings. Letters will be sent to each community to formalize everything. The agreed schedule is as follows:

Mistissini: November 6 Nemaska: November 8 Chisasibi: November 13 Eastmain: November 15 Wemindji: November 20 Waskaganish: November 22

A public notice will appear in the newspaper *The Nation* on October 5 to announce the hearings. There will be a meeting on the afternoon of October 10 with Hydro-Québec for an update on logistics and another meeting on October 25 for the presentation on the agreement between Hydro-Québec and the Grand Council of the Cree.

8. FOLLOW-UP OF WORKSHOP ON THE STATUS OF THE WOODLAND CARIBOU

This workshop involved an overview of the final report by experts. There are now 600 caribou or fewer in the three James Bay herds. The experts recommended expanding the Assinica national park project and creating two protected areas in the Waswanipi and Nemaska regions. They also proposed an end to the traditional subsistence hunt, modifying

logging practices to promote caribou, constructing as few roads as possible and reducing traffic on the 167 during calving season to encourage survival of young animals.

9. COMEX SECRETARIAT

A new Executive Secretary has been hired. On October 1-3 she will accompany Hydro-Québec on a visit to communities involved in the public consultations.

10. OTHER BUSINESS

An update on the BlackRock mine project should arrive soon. It would be difficult to complete the analysis before the end of October, so it would be best to postpone the public consultations, perhaps until early January.

Metanor recently sent us a document concerning start-up parameters for a cyanide destruction system. This document must be approved by COMEX. A draft recommendation will be prepared for the next meeting.
