The public is unanimously in favour of the project. The arrival of new families and workers in the Chibougamau area is seen as a positive impact. The project is expected to have economic spinoffs in the areas of Chapais, Chibougamau, Mistissini, Oujé-Bougoumou and Saguenay.

## 9. ROUTE 167 NORTH EXTENSION

Sandpit D-43 is located in the future ATO national park. Sandpit D-22B is located inside the park boundaries, but was withdrawn from it. In the context of this request, COMEX agreed to take no further action in relation to Sandpit D-43 given that a decision must be decreed first. Operation of Sandpit D-22B may authorized on the condition that it is at least 30 metres from a waterbody and subject to the conditions issued in the amended certificate of authorization dated August 13, 2012, for borrow pit D-22B, adjusting those conditions as necessary.
