## 1) CALL TO ORDER AND ADOPTION OF THE AGENDA

The agenda was adopted as presented.

## 2) CORRESPONDENCE AND FOLLOW-UP ACTION (APPENDIX A)

Correspondence received and sent between December 18, 2015 and February 26, 2016 is listed in Appendix A.

# 3) Project to build forest access roads "H – Section West" and "I," Matériaux Blanchet

- a) Report and recommendation
  - For discussion

The members commented on the revised version of the review report and a number of minor corrections were made. There was a discussion about the best criterion for fixing the limit of the road section that could be authorized. It was agreed that road "I" could end at its intersection with trapline W05-C. Road "H-West" could end at the northern limit of the 2013-2018 timber harvesting areas adjacent to the roads. Any project to extend roads "H-West" and "I" would require prior authorization from the Administrator.

It was agreed to incorporate the comments made at today's meeting into the review report as soon as possible and submit the new version to the members at the next meeting.

## 4) PROJECT TO BUILD A WOOD PELLET FACILITY IN CHAPAIS

- a) Planning of public hearings
  - For discussion

This project will be handled by the new chairperson once in office. Mr. Boisclair will be stepping down on April 28, 2016.

#### 5) BACHELOR LAKE MINING PROJECT

- a) Request for an amendment: extraction and processing of 600 000 additional tonnes of ore versus the report concerning the questions and comments on cyanide destruction validation tests (August 2015-3rd set)
  - For recommendation

WHEREAS, on October 22, 2016, COMEX received a request to amend the certificate of authorization to allow for extraction and processing of an additional 600 000 tonnes of ore on the Bachelor Lake property;

WHEREAS, on January 7, 2016, COMEX received the proponent's responses to the third set of questions and comments regarding cyanide destruction validation tests;

WHEREAS the proponent has not yet conducted tests to validate the effectiveness of the cyanide destruction system and validation is a prerequisite for extending mining operations on the Bachelor Lake property;

WHEREAS the request to amend the certificate of authorization in order to extend mining operations is incomplete;

WHEREAS COMEX wants to send the proponent the 44 questions/comments contained in the Committee's March 2016 review report before continuing the review process;

CONSEQUENTLY, the COMEX members decided:

#2016-0321-01: to write to the Provincial Administrator to obtain additional information on the requested clarifications.

#### 6) EASTMAIN-1-A/RUPERT HYDROELECTRIC DEVELOPMENT PROJECT

- a) Suivi de l'intégrité et de l'utilisation des frayères aménagées pour l'esturgeon jaune Suivi environnemental en phase exploitation travaux 2012 (2012 monitoring of the integrity and use of spawning grounds developed for lake sturgeon Environmental monitoring during the project's operation phase)
- b) Suivi environnemental en phase exploitation Utilisation des frayères naturelles d'esturgeon jaune dans la rivière Rupert Bilan du suivi 2010-2014 (Environmental monitoring during the project's operation phase use of natural spawning grounds by lake sturgeon in Rupert River 2010-2014 monitoring results)
- c) Suivi environnemental en phase exploitation Dérive larvaire de l'esturgeon jaune dans la rivière Rupert (secteur à débit réduit) Rapport d'étude 2012 (Environmental monitoring during the project's operation phase Lake sturgeon larvae drift in Rupert River (reduced-flow sector) 2012 study report)
- d) Suivi environnemental en phase exploitation Dérive larvaire de l'esturgeon jaune dans la rivière Rupert (secteur à débit réduit) Bilan du suivi 2010 2014 (Environmental monitoring during the project's operation phase Lake sturgeon larvae drift in Rupert River (reduced-flow sector) 2010-2014 monitoring)

WHEREAS 2014 was the last year of monitoring of lake sturgeon natural spawning grounds in Rupert River under the 2007-2023 environmental follow-up program;

WHEREAS the members went over the documents and had no comments;

CONSEQUENTLY, the COMEX members decided:

#2016-0321-02: to write to the Provincial Administrator to inform her that the COMEX members reviewed the four documents referred to above and have no comments.

## 7) CONTINUATION OF UPGRADING AND MAINTENANCE OF THE EASTMAIN ROAD

- a) Sandpit D-80
  - For discussion

WHEREAS COMEX received the impact statement for this project on December 3;

WHEREAS the members are satisfied with the information provided by the proponent;

WHEREAS the map in Appendix 3 of the document containing the proponent's responses shows the existence of a wetland close to the east side of the deposit and less than 75 m from the boundary of the extraction area, there could be a problem with erosion and transport of fine particles. The proponent will have to take precautions to minimize the impact of such occurrences and avoid altering natural drainage patterns. Work near wetlands and watercourses must be performed with the utmost care. The proponent must also implement measures to minimize erosion and the transport of sediment in the peat bog.

CONSEQUENTLY, the COMEX members decided:

#2016-0321-03: to write to the Provincial Administrator to recommend that the project be authorized with the above stipulation regarding wetlands.

## 8) ROUTE 167 NORTH EXTENSION PROJECT, MTO

- a) 2013-2015 monitoring of *Salix pseudomonticola*
- b) Environmental monitoring: operation of borrow pits less than 75 m from lakes and watercourses km 0-142
  - For discussion

WHEREAS, on January 13, 2016, COMEX received a report on the monitoring of borrow pits operated less than 75 m from lakes or watercourses as well as false mountain willow colonies;

WHEREAS COMEX took cognizance of the submitted documents on borrow pits operated less than 75 m from lakes or watercourses and has no comments;

WHEREAS the COMEX members noted that the document on false willow is the second monitoring report on this species and that the proponent has until September 2017 to demonstrate whether propagation will be necessary during the final monitoring required, the members have the following questions and comments for the proponent:

- **QC 1.** The proponent must report on the status of "Colony 20," the main colony (junction with the ramp to Albanel Lake).
- **QC 2.** The next monitoring report must contain a more detailed assessment of individual trees based on their condition (moribund, weak, average or good) and other characteristics.
- **QC 3.** Going forward, the proponent must implement recovery measures and install markers and signs indicating rare plants and prohibited activities along the road.
- **QC 4.** The proponent must specify the type of maintenance work to be carried out on road shoulders with a view to future changes if necessary.

CONSEQUENTLY, the COMEX members decided:

#2016-0321-04: to write to the Provincial Administrator to inform her that the COMEX members took cognizance of the documents on borrow pits less than 75 m from lakes or watercourses and have no comments.

#2016-0321-05: to write to the Provincial Administrator to request additional clarifications regarding false willow colonies.

Action: Send a letter to the Provincial Administrator transmitting decisions 04 and 05

## 9) RENARD DIAMOND PROJECT

- a) Amendment to the certificate of authorization: Condition 2.2 (tailings site processed kimberlite containment area)
  - For recommendation

WHEREAS, on February 19, 2016, COMEX received a request to amend the certificate of authorization for this project;

WHEREAS processed kimberlite is non-acid generating, but is potentially leachable within the meaning of MDDELCC's Directive 019 on the mining industry;

WHEREAS geochemical characterization data for processed kimberlite suggest that metal leaching will occur primarily in the short term, and considering that most of the water

seepage from the processed kimberlite containment area will be collected by foundation drains and drainage blankets and conveyed to the mine water treatment plant, COMEX considers that measures are in place to protect the environment, including groundwater;

WHEREAS COMEX notes that the proposed environmental monitoring program for the processed kimberlite containment area does not address the questions and comments previously sent to the proponent during the review of the requested amendment to the certificate of authorization for the environmental and social monitoring program, COMEX cannot recommend that the monitoring program be authorized as currently proposed. COMEX will continue reviewing this component as part of the requested amendment to the certificate of authorization for the environmental and social monitoring program.

## CONSEQUENTLY, the COMEX members decided:

#2016-0321-06: to write to the Provincial Administrator to recommend that construction, operation and closure of the processed kimberlite containment area be authorized, except for the proposed environmental monitoring program.

## 10) PUBLIC PARTICIPATION, JBACE

- a) Implementation of the recommendations regarding public participation
