1) Call to order and adoption of the agenda

The agenda was adopted as presented.

2) Adoption of the minutes of the 363rd meeting

The minutes of the 363rd meeting were adopted as presented.

Action: Translate and file the 363rd meeting minutes

3) Correspondence and follow-up action

Correspondence and follow-up action from May 9 to June 12, 2018 are presented in Appendix A.

4) Rose Lithium-Tantalum mining project, Critical Elements Corporation

Ref. No.: 3214-14-053

a. Updated environmental impact study – missing sections

> For recommendation

WHEREAS on March 28, 2018, COMEX received, for its recommendation, the sections missing from the updated environmental impact study for Critical Elements' Rose Lithium—Tantalum mining project;

WHEREAS the COMEX members reviewed the documents submitted by the proponent and would like to obtain additional information to be incorporated into a single document containing the proponent's answers to the two sets of questions sent to it, that is, the present questions and the questions sent on April 25, 2018;

WHEREAS the missing sections received on March 28, 2018 did not take into account the first set of questions and comments submitted to the proponent;

WHEREAS the COMEX members received an opinion from the archeology unit of the Social and Cultural Development Department in relation to section 8.5 of the impact study on April 6, 2018, that is, after COMEX had reviewed the impact study;

COMEX will review the information related to estimated greenhouse gas (GHG) emissions (Technical Note 2) and community participation and concerns (Chapter 4) in the light of the responses received from the proponent further to this change.

Although COMEX did not receive the opinion of the archeology unit of the Cree Nation Government's Social and Cultural Development Department until after it had sent the first set of questions to the proponent in April, the committee recommends that the proponent seek the unit's assistance for the purpose of enhancing section 8.5 (historical, cultural and archeological heritage).

CONSEQUENTLY, the COMEX members decided:

#2018-0613-01: to write to the Provincial Administrator to inform him that the COMEX members reviewed the documents submitted by the proponent and would like more information on nine questions relating to ore processing, air quality and the environmental management plan for the construction, operation and maintenance phases. The proponent must contact the CNG's archeology unit for the purpose of rounding out the information in section 8.5 of its environmental impact study.

Action: Write to the Provincial Administrator

5) Renard Diamond Project

Ref. No.: 3214-14-041

- **a.** Fish habitat compensation program Proponent's responses to COMEX's questions and comments
 - > For recommendation

WHEREAS on January 15, 2018, COMEX received, for its recommendation, the responses to the questions and comments it sent on August 31, 2017 in relation to the fish habitat compensation program for the Renard Diamond Project;

WHEREAS the COMEX members went over the proponent's responses to the committee's questions and comments and recommend that the administrator authorize one of the three developments required to implement the fish habitat compensation program and monitor the compensation measures, that is, construction of a temporary all-terrain vehicle (ATV) trail for the purpose of developing brook trout habitat in a tributary of Lake Mistissini;

WHEREAS the COMEX members have been informed of upcoming meetings between the proponent and representatives of the community of Mistissini to discuss, among other things, the two other proposed developments, namely, development of a fish habitat near the old Icon-Sullivan mine site and development of a walleye spawning site in Lake Mistissini;

The COMEX members prefer to await the outcome of those meetings before making a recommendation in respect of the other developments.

COMEX would also like to remind the proponent of condition 2.12.2 of the amended certificate of authorization issued on October 7, 2014.

CONSEQUENTLY, the COMEX members decided:

#2018-0613-02: to write to the Provincial Administrator to inform him that the COMEX members reviewed the document submitted by the proponent and recommend that he authorize the construction of a temporary all-terrain vehicle (ATV) trail for the purpose of developing brook trout habitat in a tributary of Lake Mistissini, but that they will not be making a recommendation in respect of the two other developments proposed by the proponent until after the proponent has met with the community.

Action: Write to the Provincial Administrator

6) Eastmain 1-A/Rupert diversion hydroelectric project

Ref. No.: 3214-10-017

- **a.** Request to amend the certificate of authorization 2018 master plan for restoration of disturbed sites
 - > For recommendation

WHEREAS on April 27, 2018, COMEX received, for its recommendation, a request to amend the certificate of authorization in relation to the 2018 master plan for restoration of sites disturbed by the Eastmain 1A/Rupert diversion hydroelectric project;

WHEREAS the master plan is a requirement of conditions 2.7 and 2.8 of the certificate of authorization issued on November 24, 2006 and condition 1 of the amended certificate of authorization issued on August 27, 2008;

COMEX recommends that the 2018 master plan be approved as submitted by the proponent and thinks it would be beneficial to ask the proponent for an assessment of its redevelopment program implemented nearly 10 years ago so as to take stock of the restoration of sites disturbed by the Eastmain-1-A and Sarcelle powerhouses and the Rupert diversion project.

Lastly, COMEX is waiting to receive the proponent's responses to its questions and comments concerning the permanent housing complex on the site of the temporary workcamp for Eastmain-1.

CONSEQUENTLY, the COMEX members decided:

#2018-0613-03: to write to the Provincial Administrator to inform him that the COMEX members reviewed the document submitted by the proponent and recommend that he approve the 2018 master plan as submitted by the proponent.

Action: Write to the Provincial Administrator

b. Erosion correction at KP 170 on Rupert River Planting and seeding in 2018For information

WHEREAS on March 28, 2018, COMEX received, for information purposes, a document concerning planting and seeding work in 2018 to correct erosion problems at KP 170 on Rupert River related to the Eastmain-1A/Rupert diversion project;

WHEREAS the COMEX members reviewed the document submitted by the proponent and note that the proposed tree planting and seeding is in line with expectations and, in keeping with COMEX's recommendation in 2015, they are in favour of removing reed canary grass from the hydro-seeding mixture;

CONSEQUENTLY, the COMEX members decided:

#2018-0613-04: to write to the Provincial Administrator to inform him that the COMEX members reviewed the document submitted by the proponent and find that the proposed work meets the set objectives.

Action: Write to the Provincial Administrator

7) Other business

a. Progress report on the wood pellet production plant in Chapais

The project proponent sent documents to the MDDELCC in keeping with conditions of the certificate of authorization issued on February 26, 2018.

In addition, the proponent will soon submit a request to amend the certificate of authorization to the MDDELCC because it wants to change the site of its wood pellet production plant.

COMEX is waiting to receive the documents relating to the desired amendment.

b. Action Plan 2018-2019

WHEREAS COMEX rendered an account of its Action Plan 2017-2018 adopted on June 22, 2017;

WHEREAS a number of actions initiated in 2017-2018 have been renewed in the Action Plan 2018-2019, which aims primarily to continue the initiative to ensure better integration of climate change into the project review process and communicate COMEX's achievements;

CONSEQUENTLY, the COMEX members decided:

#2018-0613-05: to adopt Action Plan 2018-2019.

Action: Linguistic revision and translation. Send the action plan to the administrators, the JBACE, COMEV, the Direction des évaluations environnementales des projets nordiques et miniers and all other relevant bodies. Post on COMEX's website.

c. Annual Report 2017-2018: clarification

The members discussed Section 3.1 ("Human and material resources") of the annual report. Suzann Méthot will rework the section and send it to Vanessa Chalifour for incorporation into Annual Report 2017-2018.

d. Documents for COMEX / Documents to be made public

COMEX has noted that the potential confidentiality of some of the essential information needed to review projects (e.g. data related to sites of interest for subsistence wildlife harvesting or to impact and benefits agreement) often raises issues among local communities and proponents, particularly whether or not the information should be made public. More in-depth discussions will be held as needed, within both COMEV and COMEX, but for now they will be on a case-bycase basis. It was suggested that Brian Craik and Daniel Berrouard raise the issue with COMEV (of which they are also members) to see how it could be taken into account when drafting directives where necessary. In the meantime, COMEX will draft a text to be posted on its website and possibly incorporated into the document on the committee's expectations in relation to consultations held by proponents. Possible solutions include greater involvement of the Cree Nation Government analysts in the handling of potentially confidential information, as well as measures allowing COMEX to be informed without necessarily posting the information on its website. The COMEX members will give more systematic consideration to the matter when reviewing projects. The committee will also draw up a list of potentially confidential information.

Action: Suzann Méthot will follow-up on the matter

e. MDDELCC public register

The information to be contained in the environmental assessment register for projects in Northern Québec is still not official, especially as regards project-related documents and follow-up/monitoring reports. Until the content of the register is official, COMEX will continue getting proponents' permission, in writing, to post their documents on COMEX's website (or access to the documents on the proponents' websites).

f. Timeline for posting documents on COMEX's website

No further discussion was needed, as the specific procedure is already set out on COMEX's website.

g. Windfall Lake Mine Project: health impact assessment pilot project

A meeting was held with the Direction de la santé publique of the Ministère de la Santé et des Services Sociaux (MSSS) to get a better grasp of what its health impact assessment pilot project associated with the Windfall Lake Mine project will be. The pilot project will form an integral part of the impact study for the project.

The COMEX members emphasized the importance they attach to the CBHSSJB's collaboration and the integration of data already produced by the Cree Nation Government. They suggested that the MSSS inform the CBHSSJB and the CNG about the pilot project.

Once the pilot project is authorized, further meetings may be held to discuss the progress of the project.
