# 5) James Bay Lithium Mine Project, Galaxy Lithium (Canada) Inc. Ref. No.: 3214-14-055

# 6) Project to increase untreated peels storage capacity for the Chapais Énergie cogeneration plant

**a.** Answers to additional questions – Request to amend the CA
For recommendation

WHEREAS on July 20, 2018, COMEX received, for its recommendation, the updated request to amend the certificate of authorization for the project to increase the untreated peels storage capacity for the Chapais Énergie cogeneration plant, and whereas it received the answers to its additional questions on January 15, 2019;

WHEREAS the COMEX members reviewed the document submitted by the proponent and recommend that the change to the project, as proposed by the proponent, be authorized on the condition that the proponent fulfil its commitments and comply with the authorization conditions. The latter are in addition to the conditions already set out in the amended certificate of authorization for the diversion of stormwater issued on January 11, 2019;
